Participation in the Environmental Farm Plan (EFP) under Year 2 (2024-2025) of the Sustainable Canadian Agricultural Partnership

Under the Sustainable Canadian Agricultural Partnership (Sustainable CAP), OSCIA delivered Environmental Farm Plan (EFP) workshops to agricultural producers and value chain partners across the province. Four EFP workshop delivery options were offered:

- 2-day in-person EFP workshop
- 1-day in-person EFP Renewal workshop
- Electronic or eEFP
- EFP webinar (NEW format offered since October 2024)




